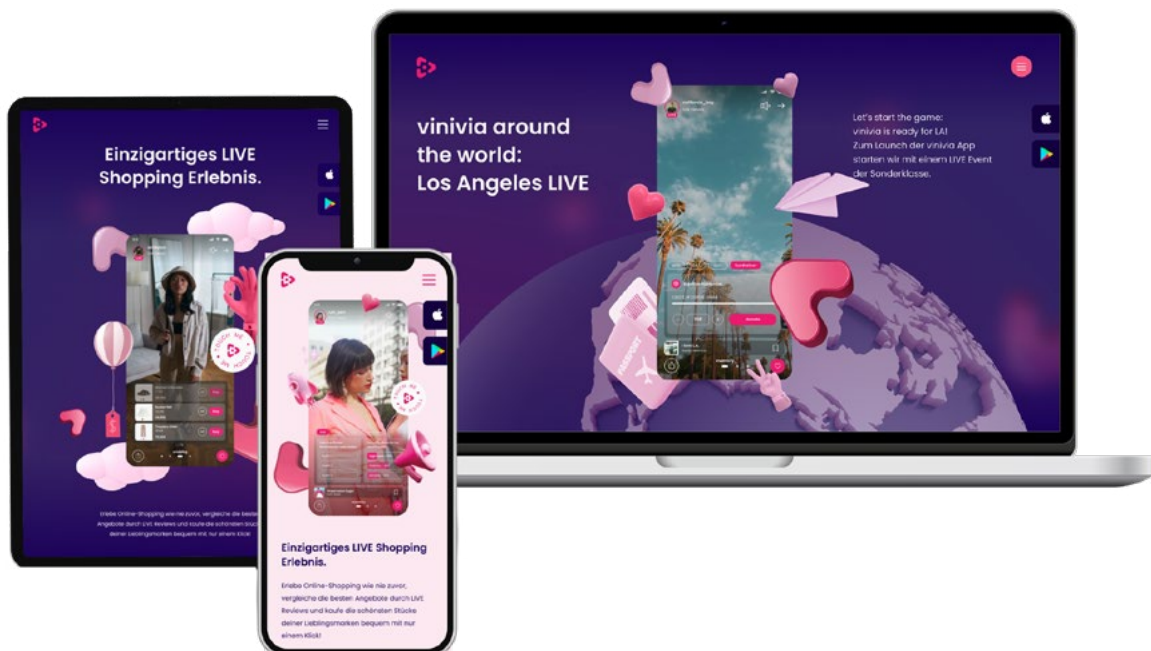


We have great news!

Whether a creator, a brand, or a viewer, Vinivia and the Apple Vision Pro open up endless possibilities for users to bring their visions and ideas to life.

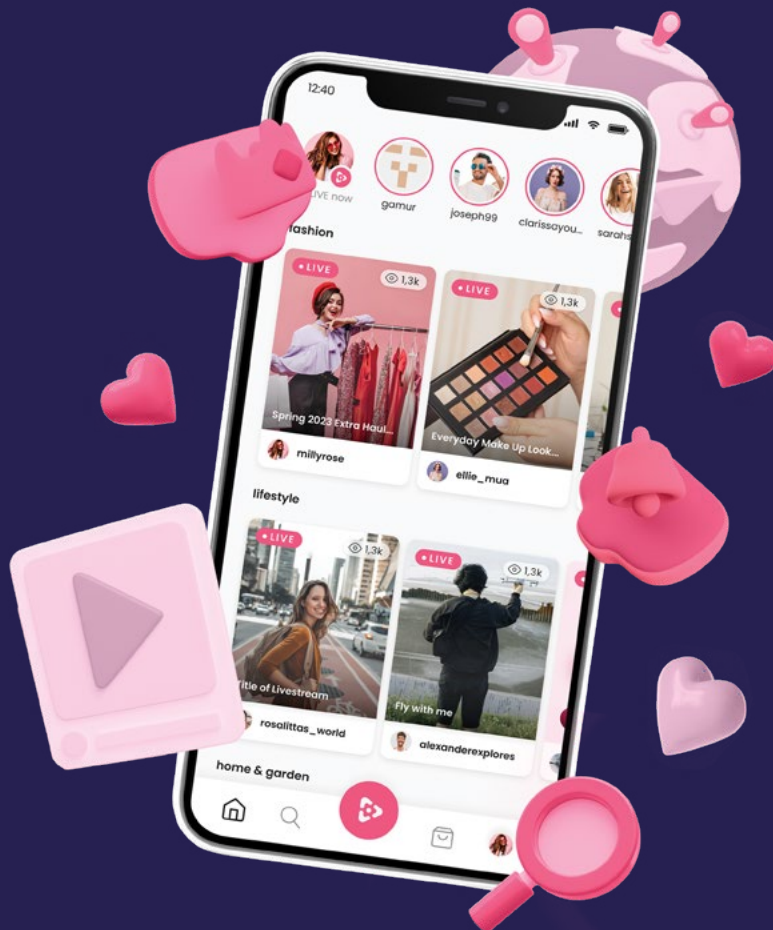

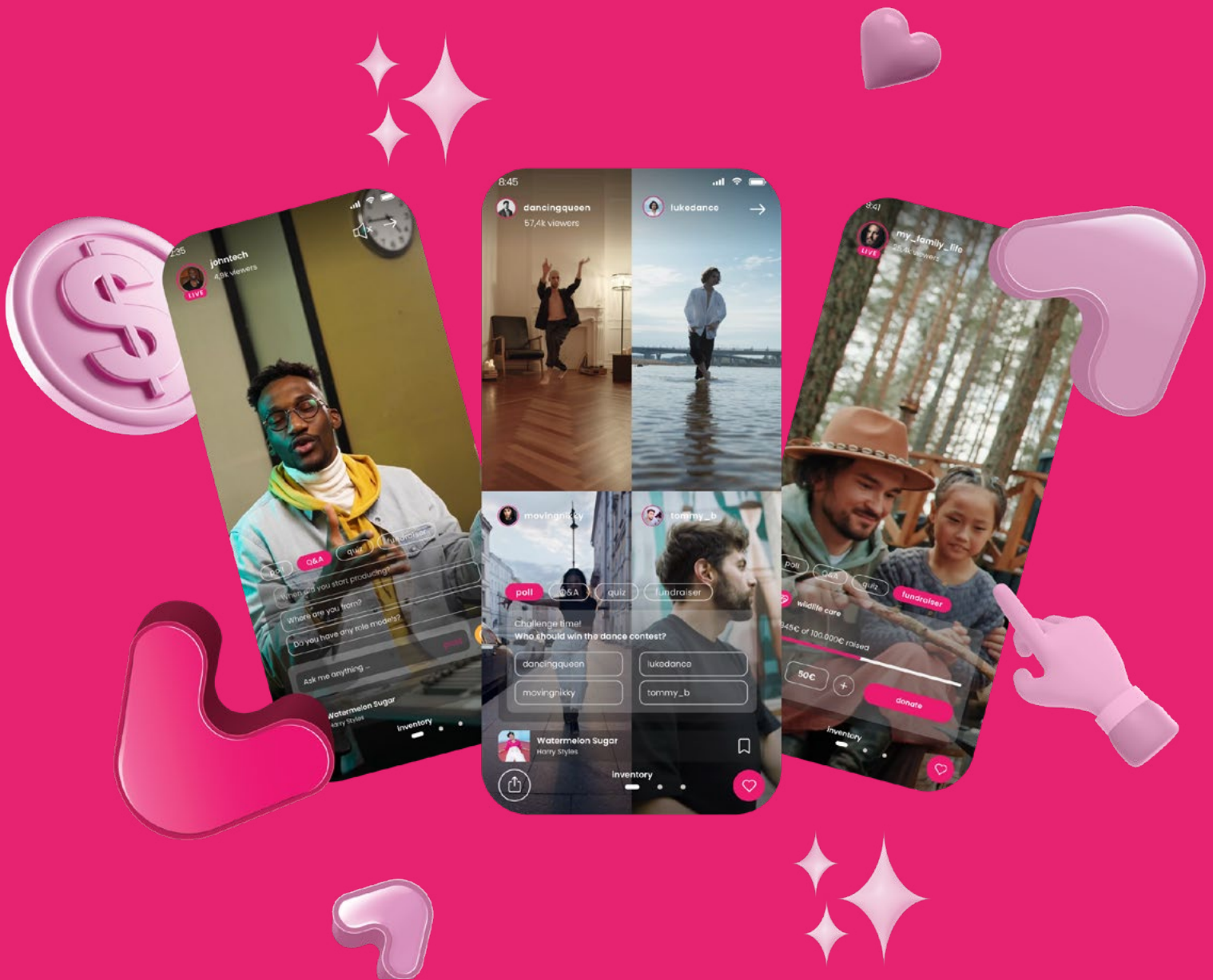
